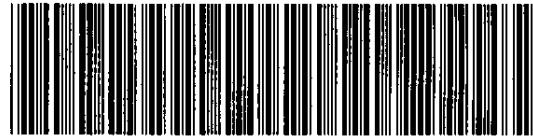

"ARTICLE VI"

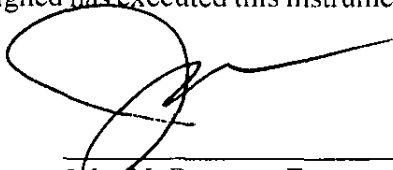
The business of the Company shall be managed by the following members:
