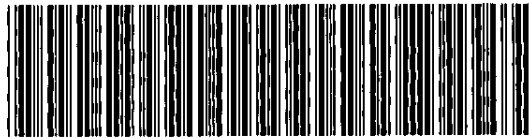

ARTICLE IV - MANAGEMENT

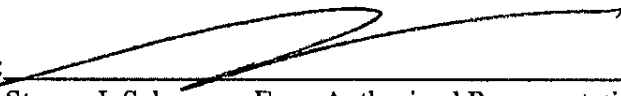

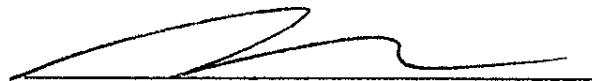
