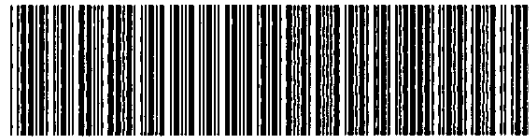

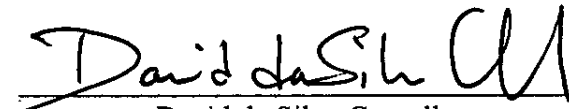

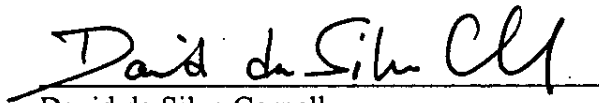
**ARTICLE VII
