

ARTICLES OF ORGANIZATION

OF

3381 WESTLUND TERRACE, LLC

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be 3381 WESTLUND TERRACE, LLC and the mailing address and street address of its principal office shall be 2408 Sofia Lane, Punta Gorda, Florida 33983, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
