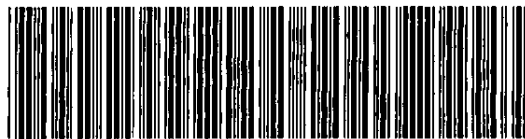

**ARTICLES OF ORGANIZATION
OF
SNJ CONSULTING, L.L.C.**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

SNJ Consulting, L.L.C.

SECOND: The latest date on which the Limited Liability Company is to dissolve is December 31, 2035.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated, Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The mailing address and street address of the initial registered office of the Limited Liability Company in Florida is 4510 Portofino Way, Suite #209, West Palm Beach, Florida 33409, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Keith A. James, Esq.

FIFTH: The mailing address and principal office of the Limited Liability Company is 7996 Crane's Point Way, West Palm Beach, FL 33412.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: Steven Amato, having an address at 7996 Crane's Point Way, West Palm Beach, FL 33412; Joseph Infante, having an address at 7996 Crane's Point Way, West Palm Beach, FL 33412, and Noreen Griffin, having an address at 2191 Snow Road, Orlando, FL 32814.

SEVENTH: The total amount of cash contributed to the Limited Liability Company, as capital, by the Members is \$1000. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter may be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.

NINTH: The membership interests of the Members are evidenced by Certificates of Membership.

TENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.


