# ARTICLES OF ORGANIZATION

OF

#### JRG FARMS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be JRG FARMS, LLC. The street address of the principal office of the limited liability company in Florida shall be 13659 Haynes Road, Dover, Florida 33527, and the mailing address shall be PO Box 1707, Dover, Florida 33527.

#### <u>ARTICLE II - DURATION</u>

The limited liability company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

#### ARTICLE III - PURPOSES AND POWERS

The specific purpose for which this limited liability company is organized is to conduct a general farming operation, which operation shall include the planting and growing of crops, the purchase and sale of produce and other agricultural products at wholesale and retail, the employment of general farm labor, and in general to perform all general business activities, related to specific purpose. The general purpose for which this limited liability company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The limited liability company shall have all the powers

granted to a limited liability company under the laws of the State of Florida.

#### <u>ARTICLE IV - REGISTERED OFFICE AND AGENT</u>

#### **ARTICLE V - CAPITAL CONTRIBUTIONS**

#### **ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the limited liability company only upon the unanimous consent of all the members.

# **ARTICLE VII - ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the limited liability company except with the unanimous written consent of all the members of the limited liability company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the limited liability company as set forth in the Operating Agreement of the limited liability company, but the transferee shall have no right to participate in the management of the business and affairs of the limited liability company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

#### <u>ARTICLE VIII - TERMINATION OF EXISTENCE</u>

The limited liability company shall be dissolved as may be provided in the Operating Agreement of the limited liability company, or upon unanimous consent of all members.

#### **ARTICLE IX - MANAGEMENT**

The limited liability company shall be managed by the member(s) in accordance with the Operating Agreement which may contain any provisions for the management of the affairs of the limited liability company not inconsistent with law or these Articles of Organization. 
