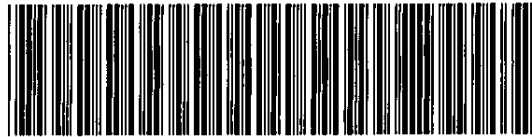



Pursuant to §608.445 of the Florida Limited Liability Company Act (the "Act"), **MUNICIPAL RESOURCES, LLC**, a Florida limited liability company (the "Company"), submits and files these Articles of Dissolution with the Florida Department of State and provides the following information:

- (1) ARTICLE FIRST: The name of the Company is MUNICIPAL RESOURCES, LLC.
- (2) ARTICLE SECOND: The Articles of Organization of the Company were filed on April 28, 2010, and assigned document number L10000045283.
- (3) ARTICLE THIRD: The effective date of the dissolution of the Company is the date of the filing of these Articles of Dissolution with the Department of State of Florida.
- (4) ARTICLE FOURTH: The occurrence which resulted in the Company's dissolution pursuant to §608.441 of the Act was the written consent, by all of the members of the Company, to dissolve the Company pursuant to §608.441(c) of the Act.
- (5) ARTICLE FIFTH: All debts, obligations, and liabilities of the Company have been paid or discharged, or adequate provision has been made therefor pursuant to §608.4421 of the Act.
- (6) ARTICLE SIXTH: All the remaining property and assets of the Company have been distributed to its members in accordance with their respective rights and interests.
- (7) ARTICLE SEVENTH: There are no suits pending against the Company in any court, and adequate provision has been made for the satisfaction of any judgment, order, or decree which may be entered against it in any pending suit.
