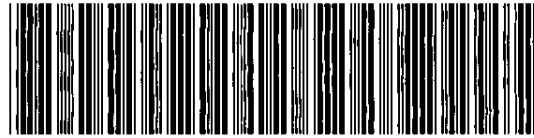

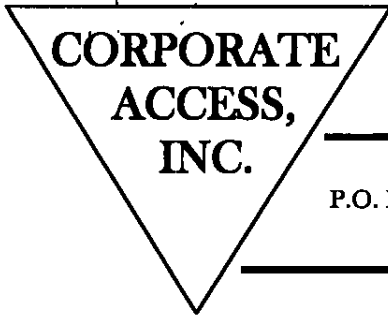

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company (the "Company") shall be Severe Clear, L.L.C.

ARTICLE II - DURATION

The limited liability company shall have perpetual duration.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

The principal place of business and the address of the Company in Florida shall be 575 North Broadway, Bartow, Florida 33830, and its mailing address is the same.

ARTICLE IV - PURPOSES AND POWERS

The name and street address of the registered agent of the Company in the State of Florida is Daniel D. Moody, 575 North Broadway, Bartow, Florida 33830.


ARTICLE VI - MANAGEMENT
