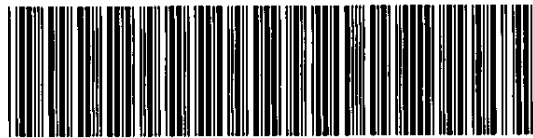

I hereby form a Limited Liability Company under the provisions set forth in Chapter 608.401 of the Florida Limited Liability Act and to that end set forth the following:

ARTICLE I

The name of the Limited Liability Company is Light Management and Leasing LLC (the "Limited Liability Company").

ARTICLE II

The address of the principal office of the Limited Liability Company where the records will be maintained pursuant to the Florida Limited Liability Act, Chapter 608.407 is 4720 Salisbury Road, Jacksonville, Florida 32256.

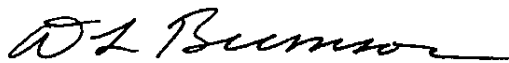
ARTICLE VI
