# ARTICLES OF ORGANIZATION OF SWFL GULF PROPERTIES, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

#### ARTICLE I - NAME

The name of the Company is SWFL GULF PROPERTIES, LLC.

## <u>ARTICLE II - DURATION</u>

The duration of the Company is perpetual.

#### ARTICLE III - ADDRESS AND PLACE OF BUSINESS
