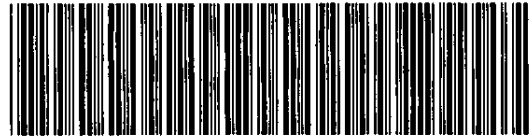

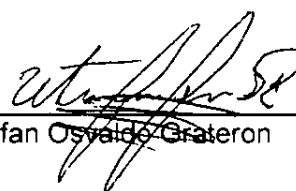
ASSIGNMENT OF PARTIAL MEMBERSHIP INTEREST

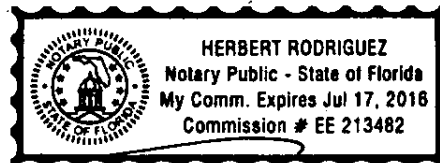
