ARTICLES OF ORGANIZATION OF CNL PUBLISHING, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is CNL PUBLISHING, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS
