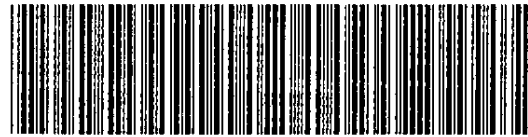



Dissolution of Connections Events LLC




