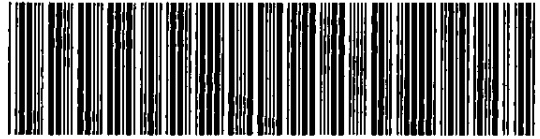

ARTICLES OF ORGANIZATION
OF

2 GUYS WEIGHT LOSS, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be 2 GUYS WEIGHT LOSS, LLC ("Company"). The mailing address and principal office of the Company is: 13450 Parker Commons Boulevard, Suite 105, Fort Myers, Florida 33912.

ARTICLE II
DURATION





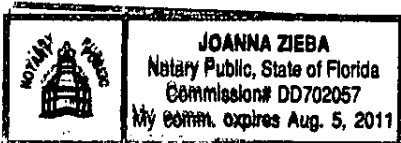
