**ARTICLES OF ORGANIZATION  
OF LANGSTON SPROWLS DESIGN GROUP LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

**Article 1 – Name**

Additional members may be admitted to the Company pursuant to Company regulations and the requirements of Chapter 608, Florida Statutes.

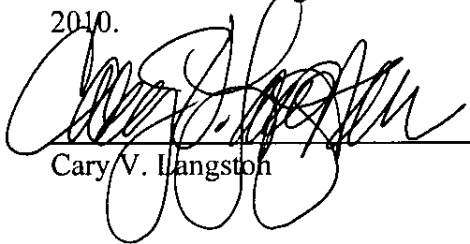
#### **Article 6 – Termination of Membership**
