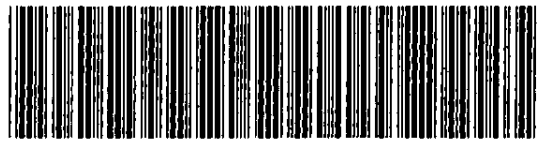

**FOURTH:** The effective date shall be March 20, 2010.




