Principal Office


The street address of the principal office of the Company shall be 1315 61st Street NW, Bradenton, Florida 34209, and the mailing address shall be the same.

Registered Agent and Office


The initial registered agent for the Company shall be THOMAS W. HARRISON, 1206 Manatee Avenue West, Bradenton, Florida 34205.
