ARTICLE IV

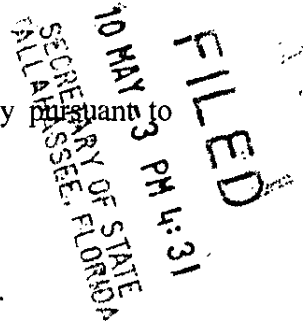
