The mailing address and principal place of business of the Company is 801 Brickell Avenue, Suite 1100, Miami FL 33131.

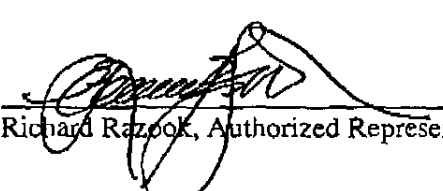
ARTICLE III**INITIAL REGISTERED AGENT**

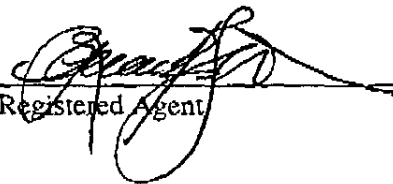
