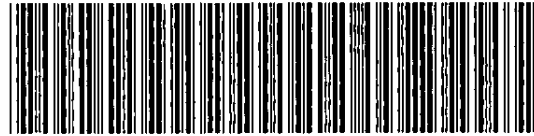

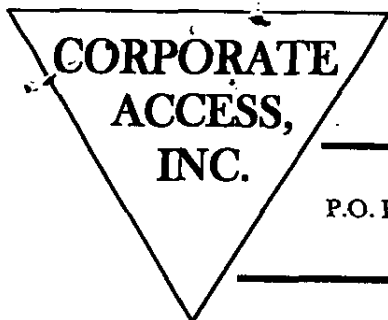

2. Article IV is amended in its entirety and the following is substituted as Article IV:


