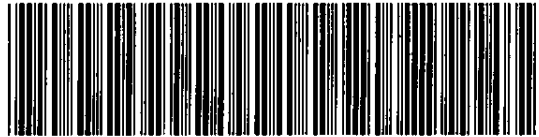



**ARTICLE I
NAME OF COMPANY**
