ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name. The name of the limited liability company ("Company") WOODHAM PALM CITY, LLC.

The preemptive right of any Member is determined by the ratio of the membership interest held by a Member to all membership interests currently outstanding.
