


ARTICLES OF ORGANIZATION CONNECT THE DOTS CONSULTING, LLC



The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

- Name. The name of the limited liability company is CONNECT THE DOTS CONSULTING, LLC (hereinafter referred to as the "Company").
