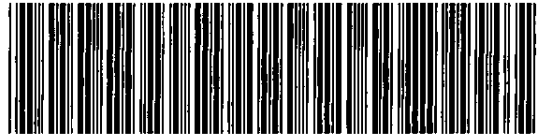

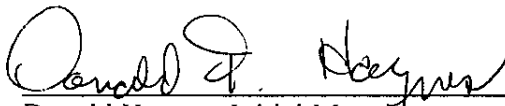
**ARTICLE VII – ADOPTION OF OPERATING AGREEMENT**

The Company shall have the power to amend or supplement these Articles of Organization when approved by unanimous vote of the Members.

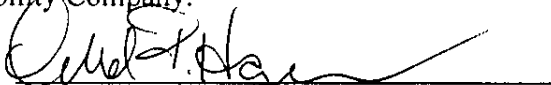
