**ARTICLES OF ORGANIZATION

1. NAME. The name of this limited liability company is SLR 101-102, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 2514 W. Edgewood Drive, Tampa, Florida 33609.


