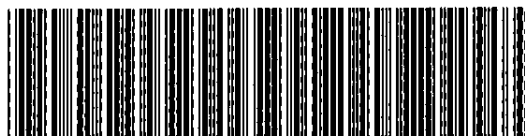

**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article I- Name

The name of the limited liability company is H & C THOMAS FARM, LLC (the "Company").

Article II- Duration

The duration of the Company shall be perpetual, unless it is sooner dissolved in accordance with applicable law or its Operating Agreement.

Article III- Mailing Address and Street Address

The Company's initial mailing address is 7031 McBride Pointe, Tallahassee, Florida 32312. The Company's initial street address is 7031 McBride Pointe, Tallahassee, Florida 32312.

Article IV- Registered Agent and Office

Article V- Additional Members

Additional members to the Company may be admitted, but only pursuant to the Company's Operating Agreement.

Article VI- Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Operating Agreement.

Article VII- Management of the Company

The Company shall be managed by its members in accordance with procedures set forth in its Operating Agreement.


Article VIII- Operating Agreement

The undersigned executes these Articles of Organization this 12th day of May, 2010.


