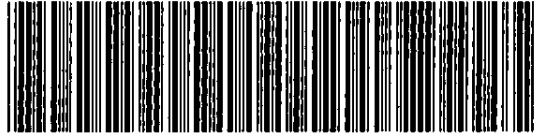

To the Secretary of State
of the State of Florida:

The undersigned, acting on behalf of one or more Members, adopts the following Articles in order to form a limited liability company (the "Company") pursuant to the provisions of the Florida Limited Liability Company Act (the "Act"):

Article 1: Name

The name of the Company is Patricia Diane, LLC.

Article 2: Duration

The Company shall have perpetual existence.

Article 3: Purpose

The Company's purpose shall consist of doing all things and performing all acts permitted a limited liability company under the Act.

Article 4: Principal Office

The mailing address and street address of the Company's principal office is 100 North Broadway, Suite 1700, Oklahoma City, Oklahoma 73102.

Article 5: Registered Agent and Registered Office

Article 6: Liability and Indemnification

The personal liability of a Member or a Manager to the Company and its creditors shall be limited to the full extent permitted by the Act, as now in effect or later amended, or otherwise permitted by law, except to the extent provided in an Operating Agreement or other document signed by such Member or Manager. The liability of a Manager and a Manager to the Company, its creditors or Members shall also be limited and every Member and Manager shall be indemnified for judgments, settlements, penalties, fines or expenses incurred in any proceeding because such person was a Member or Manager to the full extent permitted by the Act, as now in effect or later amended, or otherwise permitted by law. The indemnification allowed by this Article shall continue as to a person who has ceased to serve as a Member or a Manager and shall inure to the benefit of the person's heirs, executors and administrators.
