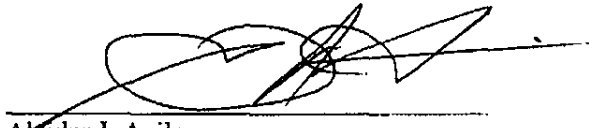
ARTICLE VII
