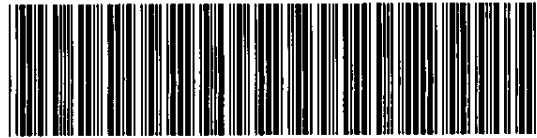

of

(A Florida limited liability company)

1. The name of this limited liability company is Urban Dynamic Communities LLC (the "Company").



Company's limited liability company regulations will be vested in the Company's members.

8. The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which he or she may be lawfully granted.


