

ARTICLES OF ORGANIZATION OF MCGEE FARMS, LLC



The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be MCGEE FARMS, LLC ("Company"). The principal place of business of the Company in Florida shall be 2709 N. Dover Road, Dover, Florida 33527, and the mailing address shall be 2709 N. Dover Road, Dover, Florida 33527.
