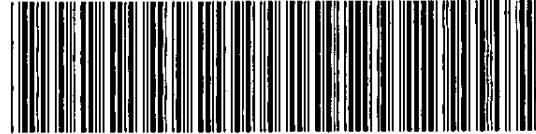

The name of the Limited Liability Company is **CONDO ACQUISITIONS GROUP, LLC** (the "Company").


**ARTICLE II - Address**
