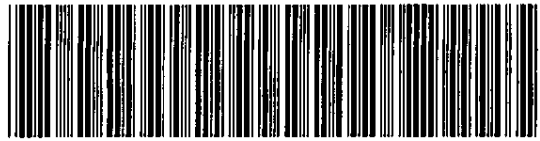

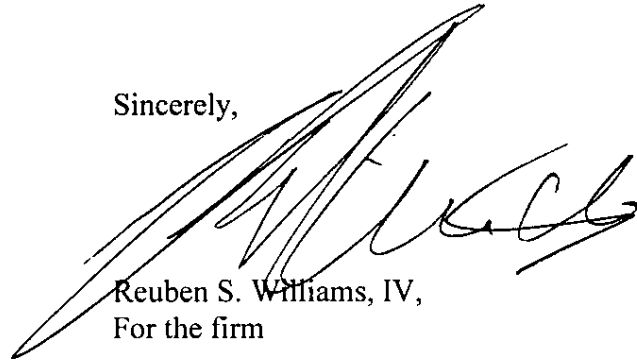

**ARTICLES OF ORGANIZATION**

**ARTICLE I - NAME**

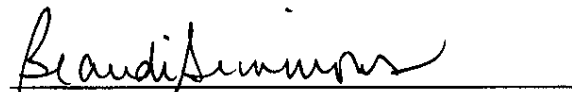
