#### ARTICLES OF ORGANIZATION

Pursuant to and in accordance with the Florida Professional Service Corporation and Limited Liability Company Act and the Florida Limited Liability Company Act (collectively, the "Act"), the following are adopted as the Articles of Organization of the professional service limited liability company organized hereby:

#### ARTICLE I NAME
