ARTICLES OF ORGANIZATION
OF
THE LAW OFFICE OF SUSAN PAI, PLLC

Pursuant to and in accordance with the Florida Professional Service Corporation and Limited Liability Company Act and the Florida Limited Liability Company Act (collectively, the "Act"), the following are adopted as the Articles of Organization of the professional service limited liability company organized hereby:

ARTICLE I
NAME

The name of the limited liability company (the "Company") shall be THE LAW OFFICE OF SUSAN PAI, PLLC.

ARTICLE II
DURATION

Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined in §608.402(24) of the Act) of the Company, the period of its duration shall be perpetual.

ARTICLE III
ADDRESS

The mailing address and the street address of the principal office of the Company shall be 3955 Riverside Avenue, #2F, Jacksonville, Florida 32205.

ARTICLE IV
REGISTERED AGENT

The registered office of the Company shall be 3955 Riverside Avenue, #2F, Jacksonville, Florida 32205, and its registered agent at such office shall be Susan Pai.

ARTICLE V
PURPOSE

The purpose for which the Company is organized is to engage in the practice of law and all other activities incident thereto in compliance with applicable law.

**ARTICLE VI
ADMISSION OF NEW MEMBERS**

Except as set forth in the Operating Agreement, no additional members shall be admitted to the Company except if they are an attorney licensed to practice law in Florida or any other jurisdiction, and with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE VII
CONTINUATION OF BUSINESS**

The remaining members of the Company may continue its business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of the member or members in the Company as provided in the Act or the Operating Agreement of the Company.


**ARTICLE IX
MANAGEMENT**

The Company will be a manager-managed company managed in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company.
