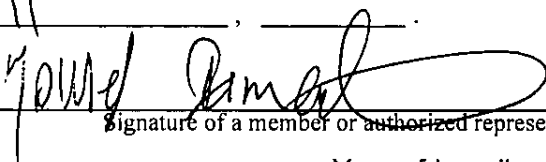

ADONDUM TO THE ARTICLES OF *Organization*

The members of Indopal, LLC agreed to replace items on Article III of the Article of *Organization* read as follows:

- 1- Mr. Narendra H Patel and Mr. Hitesh R Shroff will provide the necessary money to purchase any property all members agreed on.
