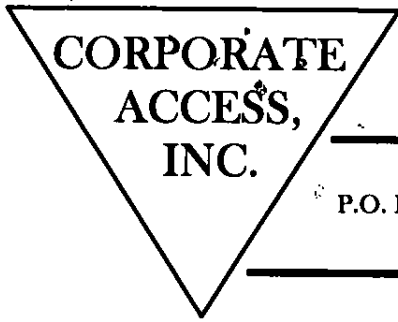

ARTICLE IV - MANAGEMENT

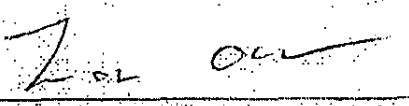
