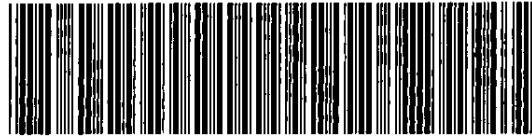

  - b. A-B Amusement LLC surviving members will control the sale of; and reserve first right to acquire the deceased/incapacitated member's Capital Stock.
    - i. The acquisition price will be in direct proportion to the assessed value of the deceased/incapacitated member's Capital Stock; less any fees incurred in the transfer of ownership of said Capital Stock.
    - ii. Method of payment to the deceased/incapacitated member's Estate, or Power of Attorney will be determined, and agreed upon by all parties involved.

## SALE/TRANSFER OF OWNERSHIP TO THIRD PARTY

In the event any member wishes to sell, or transfer ownership of any part of, or all of their percentage of Capital Stock to any third party. The following shall apply:

1. All members of A-B Amusement LLC **must agree** to any third party sale or transfer of ownership.
2. A cash value of the percentage of Capital Stock to be sold/transferred will be assessed.
3. The acquisition price will be in direct proportion to the assessed value of the percentage of the member's Capital Stock to be sold.
4. The purchasing third party will be responsible for any fees incurred in the transfer of ownership of said Capital Stock.


