The name of the Limited Liability Company is CRIS CAB PRODUCTIONS LLC (the "Company").

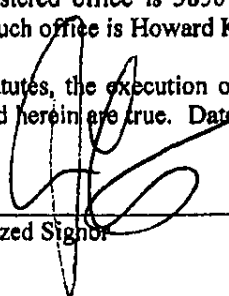

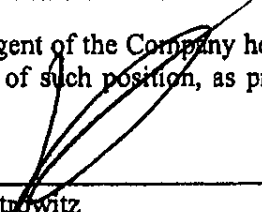
