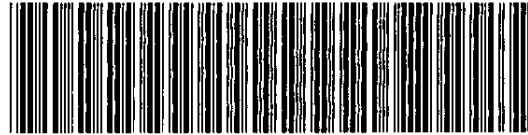

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:


1. The name of the Limited Liability Company shall be ZORGS USA, LLC.
2. The duration of the Limited Liability Company shall be perpetual.
3. The mailing address and street address of the principal office of the Limited Liability Company is 17525 Seidner Road, Winter Garden, Florida 34787.
4. The initial Registered Agent of the Limited Liability Company is Robert T. Magill, Esquire, whose address is 1234 East Concord Street, Orlando, Florida 32803.
5. The initial members of the Limited Liability Company are DAVID C. NETZORG, 17525 Seidner Road, Winter Garden, Florida 34787, and COREY S. NETZORG, 28 Oakdale Street, Windermere, Florida 34786. Additional members may be admitted to the Limited Liability Company, only upon the unanimous consent of the existing members.
6. In the event of the death, retirement, resignation, expulsion, or bankruptcy (defined as the filing of any Petition for Bankruptcy in the appropriate court of jurisdiction, either voluntary or involuntary) of a member, the remaining member or members of the Limited Liability Company shall have the right to continue the operation of the business and of the Limited Liability Company. A member may be expelled only upon the unanimous consent of every other member, and in no event shall take place as a result of the vote of fewer than two (2) members of the Limited Liability Company.
7. The management of the Limited Liability Company is reserved to the members, upon majority vote. The members are empowered, nevertheless, to appoint agents or officers of the Limited Liability Company, who will have the powers enumerated to them by a resolution of


