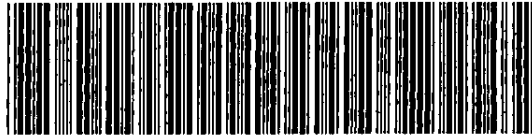

**ARTICLES OF ORGANIZATION  
OF  
SARAS, L.L.C.**

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: SARAS, L.L.C.

2. Existence. The Company shall have perpetual existence commencing with the date of filing.

3. Location. The street address of the principal office and mailing address of the Company is 5715 NW 57<sup>th</sup> Way, Gainesville, Florida, 32653.

4. Purpose. The purpose for which the limited liability company is organized is to practice real estate management.
