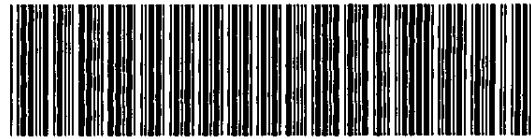





I. Article VIII shall be added to the Articles of Organization as follows:


ARTICLE VIII – OFFICERS OF THE COMPANY
