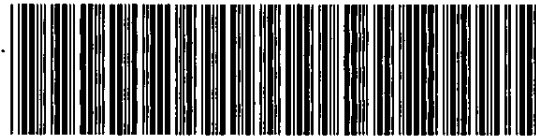

The undersigned, certifies that:


