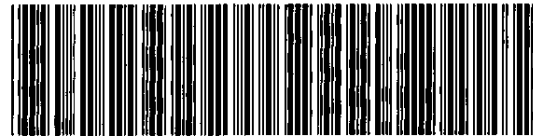

**ARTICLES OF ORGANIZATION  
OF

The undersigned, being authorized to execute and file these Articles under the Florida Limited Liability Company Act (the "Act"), hereby certifies that:

FIRST: The name of the limited liability company (the "Company") is:

**GEMINI GROUP SERVICE, LLC**

SECOND: The mailing and the street address of the principal office of the Company in this State is: 19027 North Frederick Avenue, Gaithersburg, Maryland 20879.

THIRD: The name and street address of the Company's registered agent in this State are: Registered Agents Legal Services, LLC, 155 Office Plaza Drive, Suite A, Tallahassee, Florida 32301.


