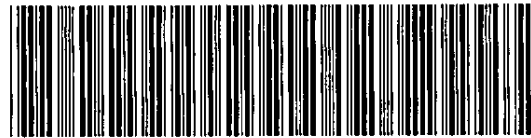

The Company is to be a member-managed company.

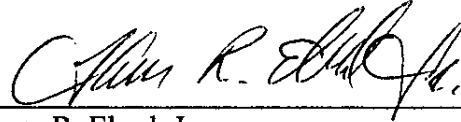
ARTICLE V - EFFECTIVE DATE

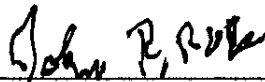
