ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF THRIFT MART, LLC

- 1. Articles of Organization for Thrift Mart, LLC, were filed on May 28, 2010, with the Florida Secretary of State and assigned document number L10000058202.
- 2. The following <u>Article 14. Officers</u> is adopted by the limited liability company and shall be part of the Articles of Organization for the company:

14. OFFICERS

The Company may have officers. The Managers shall be authorized to appoint officers of the Company.
