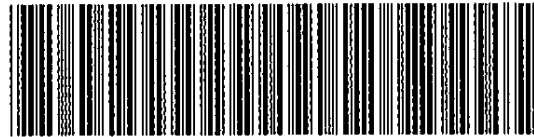

**ARTICLES OF ORGANIZATION

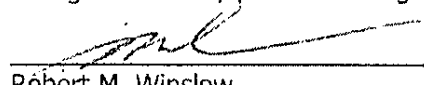

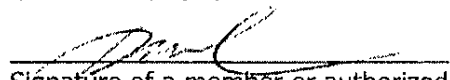
ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS
