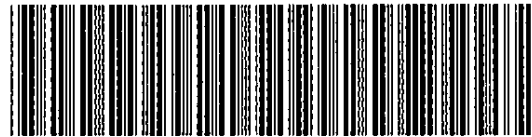



ADMISSION OF ADDITIONAL MEMBERS




