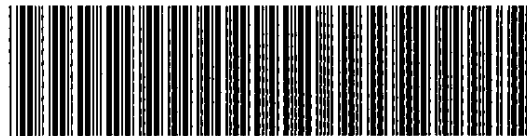

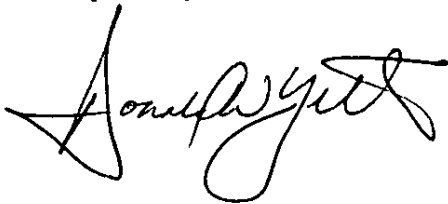

ARTICLES OF ORGANIZATION

OF

301 STORAGE, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **301 STORAGE, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 5919 Riverview Blvd, Bradenton, Florida 34209.
