

ARTICLES OF ORGANIZATION



4 ELEMENTS CLEANING SERVICES, LLC



ARTICLE 1 - NAME

The name of the limited liability company shall be 4 ELEMENTS CLEANING SERVICES, LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 325 South Biscayne Boulevard, #1414, Miami, Florida 33131 and the mailing address shall be the same.

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
