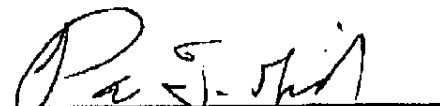

ARTICLE V - MANAGEMENT


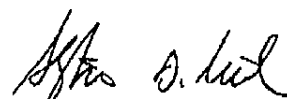
